

RIGHT TO INFORMATION ACT 2005

The Freedom of Information Act 2002 was replaced by the Right to Information Act. 2005 and received the assent of the President of India on 15-6-2005 and it was published in the Gazette of India on 21-6-2005.

" Information" means any material in any form, including records, documents, memos, e-mails, opinions, advice, press releases, circulars, orders, logbooks, contacts, reports, papers, samples models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force :
