1. Parties:

The Memorandum of Understanding (Here in after referred to as MOU) is made and entered into by and between the

> a. Department of Botany, Smt.Kandukuri Rajya Lakshmi College for women, Rajamahendravaram, East Godavari District. And

b. Department of Botany SKVT Degree College, Rajamahendravaram, East Godavari District.

2. Purpose:-

The purpose of this MOU is to promote and enrich teaching and learning process through exchange of faculty for guest lectures and to provide an opportunity for the students to teach the peers.

3. Activities:-

The two institutions agree to:

- A. Encourage the development of research projects involving faculty and students from both the parties.
- B. Cooperate with each other in the conduct of guest lectures /invited talks and in organizing various academic and laboratory oriented practical's, seminars, symposia, workshops, fests, events and the competitions such as quiz, elocution, essay writing, role plays and the like by students at each other institutions.
- C. Facilitate party 1 to conduct outreach training programs to all the faculty and students of party 2 in the areas of research field in order to enhance the teaching skills and competencies of the latter both in terms of subject and knowledge and effective implementation of pedagogical tools in student centric method.

4. Duration of the agreement:

This MOU is valid for TWO years i.e., 2021 to 2023, starting on the date that is signed by the Smt.Kandukuri Rajya Lakshmi College For Women, Rajamahendravaram and SKVT Degree College, Rajamahendravaram. The MOU can be terminated by other one of the two parties with their return notification 3 months in advance of the anticipated termination. It may also be extended by mutual agreement of the parties involved.

Any difficulty or controversy that may arise between the collaborating institutions will be amicably resolved by the authorities of both institutions.

5. Responsibilities of the parties:

The signatories of both parties permit their faculty and students to attend and participate in guest lectures, invited talks, seminars, workshops, symposium along with various other science departments' oriented academic competitions such as quizzes, role plays, elocution, essay writing, performances of skills and the like.

The parties shall entrust a faculty member in their respective institutions to liaison between the parties.
