ORDER:

In the interest of public, after careful review of the policy of providing grant-in-aid to Private Educational Institutions in the State, the Government has issued a policy, vide G.O 1st read above, for facilitating takeover of voluntarily willing Private Aided Degree Colleges including minority institutions by the Government.

2. In pursuance of the policy issued by the Government, the Commissioner of Collegiate Education, A.P has submitted a proposal for takeover SKR College for Women, Rajamahendravaram, Eat Godavari District, vide reference 2^{nd} read above, in view of the voluntary willingness submitted by the Correspondent/Management of the institution for surrender of the entire institution along with assets without any liabilities so as to convert the institution as a Government Educational Institution and the willingness of all the aided staff of the institution for absorption into Government.

3. Accordingly, the Government, after careful examination of the proposal submitted by the Commissioner of Collegiate Education, hereby accepts the request of the Assistant Commissioner & Correspondent of the SKR College for Women, Rajamahendravaram, Eat Godavari District for surrender of the entire institution along with assets and the existing staff whose details are provided in the Annexure and thereby accords permission to the Commissioner of Collegiate Education for takeover of the institution and to convert the institution as a Government Educational Institution subject to other terms and conditions as detailed below:

a) The process of such takeover of institution and the existing staff of the institution shall be as per the policy issued vide G.0.1st read above;

- b)From the date of issuance of this order, any asset (either movable or immovable) of the said institution shall not be disposed of / used for the purposes other than for which it was granted / allotted / donated without prior approval of the Government;
- c) From the date of execution of an irrevocable and unconditional registered deed of conveyance by the correspondent / management for surrender of the management and assets (movable and immovable) without any compensation payable by the Government, the institution shall be a Government Educational Institution with the same name i.e, "SKR Government Degree College (Women), Rajamahendravaram, Eat Godavari District ".
- d) All the duly sanctioned aided posts under teaching and non-teaching categories so far for the institution shall stand surrendered to the Government and all such posts shall be treated as regular posts of such Government Educational Institution in lieu of the grant-in-aid posts for all practical purposes;
- e) All the aided staff of the institution shall be absorbed into Government against such regular posts subject to the Special Service Rules to be issued separately that shall be binding on the aided staff who are willing to be absorbed into Government as the absorption is based on their willingness to do so;
- f) All such aided staff shall be deemed to have been appointed by transfer into the Government and they may be continued in the same institution for now and their salary shall be paid duly extending other benefits such as GPF/CPS, APGLI, LTC, EHS etc. suitably as per their entitlement on par with other Government Staff;
- g) The existing unaided staff of the institution, whose details are provided in the Annexure, shall be continued on outsourcing basis subject to submission of a legally binding undertaking by them declaring that they are fully aware of the prohibitory clauses of Act 2 of 1994 (A.P. Regulation of Appointments to Public Services & Rationalization of Staff Pattern and Pay Structure Act, 1994) and they should never seek recourse for regularization now or later on what-so ever grounds;
- h) In case of unaided staff who categories are not covered under the existing outsourcing policy of the Government, the Commissioner of Collegiate Education shall send proposals to the Government immediately for finalizing the pay and conditions of service for such categories;
- i) The renewal of all the outsourcing contracts shall be completed by Commissioner of Collegiate Education for all the competent candidates before the commencement of every academic year duly considering the requirement of the institution in view of the vacancies, workload, student strength etc.;
- j)Further, the Commissioner of Collegiate Education shall also send proposals at the earliest for sanction/ conversion of any posts and closure/conversion of courses duly analyzing the viability of the existing aided and unaided courses in the institution;

- k) Without any prejudice, all the pending enquiries and disciplinary or other legal proceedings against the management or the staff of the said institution shall continue;
- All the pending proposals till date for regularization of individuals into grant-inaid under teaching and non-teaching categories for the institution shall be treated as not feasible, as the cause does not survive any more, except for the posts already covered by interim/final orders of the Hon'ble Courts as on the date of issuance of this order;
- m) Additionally, the Commissioner of Collegiate Education shall accommodate any existing student of the said institution into any other Degree College of the student's choice only if the student wants to migrate to any other Government Degree College in the State;
- n) Furthermore, the working committee member(s) of the society/trust of the institution may be included in the "College Planning and Development Council", if they desire so, to extend their services further for the development of the institution.

4. In this regard, the Commissioner of Collegiate Education, the Secretary of A.P. State Council of Higher Education, the Secretary, A.P. Higher Education Regulatory and Monitoring Commission, the Registrar of the concerned affiliating University, and Social Welfare Department shall take further necessary action with respect to conversion of the institution and the aided staff, admissions, fee fixation, affiliations, and scholarships respectively.

5. This order is issued with the concurrence of the Finance Department vide their U.O.No.HROPDPP/65/2022-HR.I (Computer No.1675877, dated:28.03.2022.

While enclosing a copy of the above Government Orders, it is informed that the Government accorded permission to the Commissioner of Collegiate Education, Andhra Pradesh, Vijayawada to takeover SKR College for Women, Rajahmahendravaram, East Godavari District along with assests and the existing staff whose details are provided in the Annexure and thereby accorded permission to the CCE for takeover of the institution and to convert the institution as a Government Educational Institution subject to the conditions at para No.3 a) to n) of the above G.O.

Accordingly, <u>the Regional Joint Director of Collegiate Education</u>, <u>Rajamahendravaram/ The Principal</u>, <u>Government Degree College (A)</u>, <u>Rajamahendravaram</u> is appointed as Special Officer and is hereby directed to take over all the assets (movable and immovable) without any compensation payable by the Government by executing an irrevocable and unconditional registered deed of conveyance by the Assistant Commissioner & Correspondent, SKR College for Women, Rajamahendravaram, E.G District.

Further, the Regional Joint Director of Collegiate Education, Rajamahendravaram, E.G.District. is directed to take over the Institution along with assets (Movable and Immovable) subject to following conditions and submit a detailed report to the Commissioner of Collegiate Education immediately for taking further necessary action this matter.

- i. The management should transfer all the movable properties and assets without liabilities to the Government free of cost.
- ii. The management should transfer all the immovable properties through a deed of conveyance to the Government. The Deed of conveyance should be registered afterwards.
- iii. Only qualified, willing and suitable persons will be absorbed into the Government service against the posts as per the existing service rules.
- iv. The Liabilities, if any, also be settled by the Society, before takeover of the College.
- v. To obtain individual legally binding undertaking by the staff declaring that they are fully aware of the prohibitory clauses of Act 2 of 1994 (A.P. Regulation of Appointments to Public Services & Rationalization of Staff Pattern and Pay structure Act, 1994) and they should never seek recourse for regularization now or later on what-so ever grounds.

Further, it is informed that proposal has been submitted to the Government to finalize the pay and conditions of services of the un-aided Teaching and Non-teaching staff.
